Winrock International (Winrock) is implementing the USAID Reducing Pollution Activity, funded by the United States Agency for International Development (USAID), Prime Award Number: 72044021CA00002 in close collaboration with the Vietnam Environment Administration (VEA) of the Ministry of Natural Resources and Environment (MONRE). The Reducing Pollution Activity is supporting Vietnam's efforts to address environmental pollution challenges through a series of locally driven initiatives using a collective impact approach.

Winrock is pleased to announce this Request for Application (RFA) that seeks innovative and creative approaches from eligible Vietnamese non-governmental organizations to develop a collective impact initiative to address the challenge of reducing air pollution from two key sources in Vietnam.

*Two (2) separate grants will be issued under this RFA, one for each topic:*

Grant #1: Air Pollution from Open Burning

Grant #2: Air Pollution from Road Transportation

Winrock invites organizations interested in potential funding to submit applications outlining their approach and proposed activities to build a collective impact initiative that reflects the goals and objectives of the project. *Applicants may submit a proposal for one grant of their choice, or both.*

Winrock will hold an online pre-application conference on 23 August 2022 for potential applicants to learn more about the project and this RFA, and to ask questions. Questions may also be submitted by email to the Winrock Grants Management team following the submission process described in the documentation below.

Full applications received by the submission deadline of 30 September 2022 and meeting eligibility conditions will be considered for evaluation. Applicants should carefully follow all instructions in the RFA documentation that follows.

Winrock expects two (2) separate grants will be issued under this RFA, but reserves the right to award fewer or none based on the quality of applications received and availability of funding.

### SECTION 1: PROGRAM DESCRIPTION

#### 1.1 PURPOSE AND BACKGROUND

The purpose of this RFA is to solicit applications from prospective grantees to support Winrock International (Winrock) in the implementation of USAID Reducing Pollution Activity (hereafter referred to “Reducing Pollution Project” or “Project”, funded by the United States Agency for International Development (USAID), Prime Award Number: 72044021CA00002. Winrock is implementing the Activity in close collaboration with the Vietnam Environment Administration (VEA) of the Ministry of Natural Resources and Environment (MONRE).

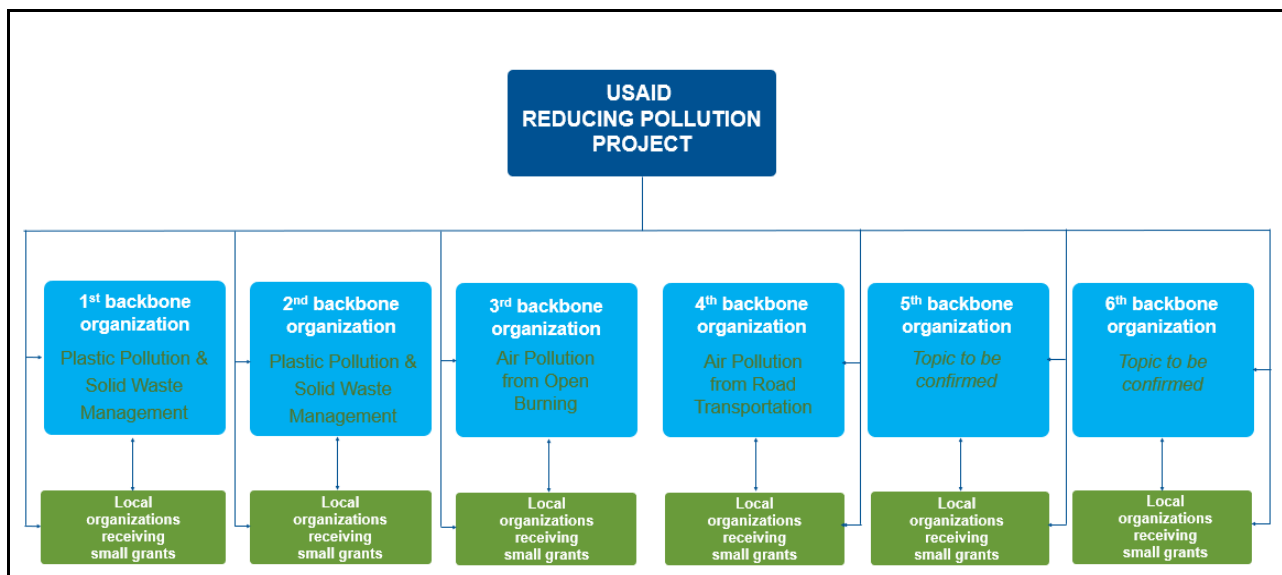
The Reducing Pollution Project is supporting Vietnam’s efforts to address environmental pollution challenges through a series of locally driven initiatives using a collective impact approach<sup>1</sup>. Collective impact addresses complex challenges by mobilizing diverse actors to collaborate, identify ways to solve a shared problem, and take actions based on their roles and comparative advantages. The Reducing Pollution Project demonstrates clear connections between environmental benefits and other social benefits, including public health, employment, and sustainable economic growth.

To achieve the ultimate goal of reducing environmental pollution in targeted areas, Winrock will facilitate a portfolio of multi-stakeholder collective impact initiatives (CIIs). Each collective impact initiative will be led by a local organization, who will serve as the “backbone organization” to lead a series of connected activities to address a key pollution issue and develop a network of motivated stakeholders from communities, local governments, academic institutions, and private sectors working together to identify solutions to the pollution challenges. The Reducing Pollution Project expects to identify six different pollution challenges to be addressed through such collective impact initiatives.

As part of each collective impact initiative, the Reducing Pollution Project will also provide a series of small grants to community organizations, advocacy groups, universities, and/or research institutes to complement the activities covered under the grant(s) awarded under this RFA.

Each collective impact initiative will follow the collective impact framework to build momentum toward policy development, policy implementation, and behavior changes. This process expects to attain the following intermediate results:

- **Intermediate result 1:** Backbone organizations capacity are strengthened;
- **Intermediate result 2:** CII progress toward impact and sustainable goals with strengthened networks of local organizations, government, private sector, and academic institutions working together to prevent, mitigate, and/or reduce environmental pollution; and
- **Intermediate result 3:** Transparency of data and information to inform policy making and promote behavior change is increased.

To measure the above results, currently, the Reducing Pollution Project has the following indicators:

1. Number of laws, policies, regulations, or standards formally proposed, adopted or implemented
2. Percent of organizations with improved performance
3. Number of civil society organizations (CSOs) engaged in advocacy interventions
4. Value (\$) of non-donor resources mobilized for local development priorities
5. Number of local mechanisms for citizens to engage their sub-national government
6. Number of persons trained to advance outcomes consistent with gender equality and female empowerment through their roles in public or private sector institutions and organizations
7. Number of direct beneficiaries of Collective Impact Initiatives
8. Number of indirect beneficiaries of Collective Impact Initiatives

Additional indicators related to project goals, such as pollution reduction and/or behaviour change, will be identified based on the selected collective impact initiatives.

This Request for Applications (RFA) is focused on the challenge of reducing air pollution in Vietnam from two key sources of air pollution. **Two separate grants will be issued under this RFA**, one for each topic:

- Grant #1: Air Pollution from Open Burning**
- Grant #2: Air Pollution from Road Transportation**

Each selected grantee will serve as the “backbone organization” to lead a collective impact initiative to address the targeted source of air pollution.

## 1.2 OBJECTIVE OF COLLECTIVE IMPACT INITIATIVES

Environmental pollution in general, and air pollution in particular, is becoming increasingly serious with negative impacts on people's quality of life. Air pollution is harmful to human health and can lead to a range of harmful diseases. The published estimates of the death toll from air pollution cover a wide range, as outlined in the graphic below.

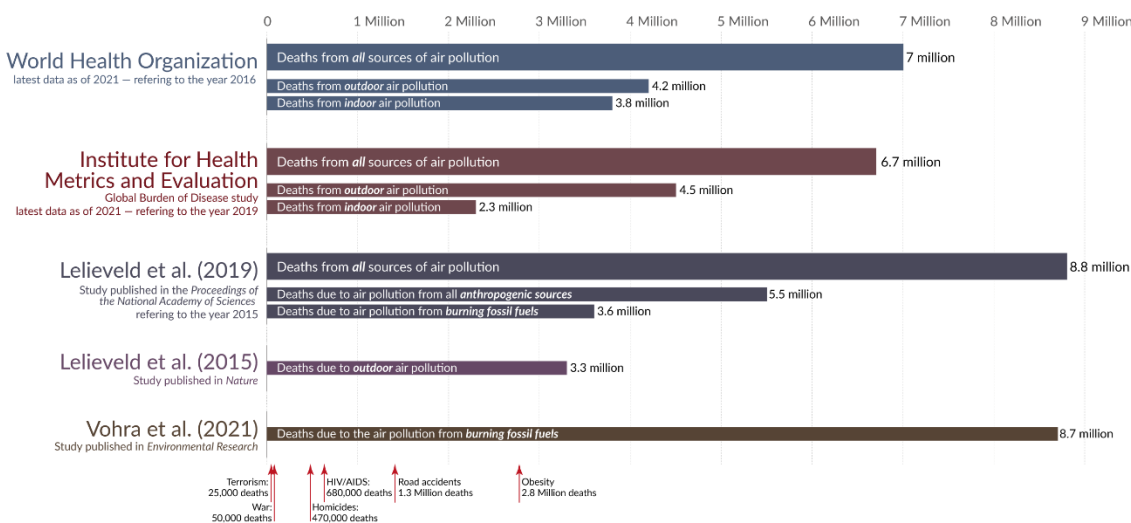
### How many people die from air pollution each year?

'All sources' includes both anthropogenic and natural sources:

- The largest source of natural air pollution is airborne dust in the world's deserts. Other natural sources are fires, sea spray, pollen, and volcanoes.
- Anthropogenic sources include electricity production; the burning of solid fuels for cooking and heating in poor households; agriculture; industry; and road transport.

The number of deaths attributed to outdoor air pollution ranges from 3 million to almost 9 million per year. In addition to its effects to human health, air pollution also harms plants and animals, production materials and contributes to global issues such as global warming, decreases in the ozone layer, acid rain, and others.

According to Environment Performance Index 2022<sup>2</sup>, Vietnam is currently ranked in the top 10 most air polluted countries in Asia, with the country's air pollution index often reaching dangerous levels. Air pollution in Vietnam is concentrated in big cities and urban areas with increasing dust pollution, especially pollution caused by PM<sub>2.5</sub> fine dust.

According to the State of PM<sub>2.5</sub> in Vietnam in 2019-2020 report, based on multisource data<sup>3</sup>, in 2020, 10 out of 25 provinces and cities in the North Region (accounting for 40%) had the average annual concentration of PM<sub>2.5</sub> fine dust exceeding the national standard<sup>4</sup>, including:

- Bac Ninh (30 - 35.5 µg/m<sup>3</sup>),
- Hung Yen (28.7 - 35.8 µg/m<sup>3</sup>),
- Hai Duong (25.5 - 34.9 µg/m<sup>3</sup>)
- Hanoi (21 - 34.6 µg/m<sup>3</sup>)

- Thai Binh, Nam Dinh, Hai Phong, Ha Nam, Ninh Binh, and Vinh Phuc.

Ho Chi Minh City ranked 11<sup>th</sup> among provinces and cities with the highest annual average concentration of PM<sub>2.5</sub> dust.

According to the same report, the main causes of air pollution came from the following sources:

- Burning agricultural by-products (40%),
- Conventional Cooking (17%),
- Transportation (13%),
- Forest fire (12.7%),
- Industrial activities (11%),
- Thermal power plants (3.3%).
- Other sources (3%)

In order to address these key issues, this RFA focuses on supporting two separate initiatives to reduce air pollution from: i) open burning; and ii) road transportation, with specific objectives and locations as follows.

### **Grant #1: Air Pollution from Open Burning:**

Open burning of agricultural by-products and household waste is a significant source of toxic air pollutants. In many parts of Vietnam, agricultural by-products are still burned in the open and there is no harmonized solution to reduce burning practices. At the same time, many households and communities burn domestic waste because of weakly coordinated garbage collection activities. There is a lack of specific regulations on open burning, limiting opportunities to effectively manage this source of air pollution.

Grant #1 under this RFA seeks to address these challenges and achieve the following objectives:

- Build a network of government, business, and community actors that works together through coordinated activities towards a common agenda of reducing air pollution from open burning
- Enable development and application of innovative technology, tools, and approaches to reduce air pollution from open burning and mitigate its impacts, including through public-private partnerships.
- Identify opportunities for research on specific health risks from air pollution from open burning (further grant funding for such research activities will be funded separately through Reducing Pollution) and/or the impact of open burning on indoor air quality.

Grant #1 will focus on the following geographic locations:

- Hanoi
- Provinces around Hanoi

### **Grant #2: Air Pollution from Road Transportation:**

Transport activities are considered a source of air pollution, especially in urban areas with high traffic density. In 2019, there were 3,673,065 cars in Vietnam (up 12.2% compared to 2018), and tens of millions of bikes and motorbikes in circulation. Passenger transport reached 5,143.1 million trips (up 11.2% compared to 2018). There is a large number of old motorbikes in circulation, and there is no regulation on motorcycle emissions which affects many motorcyclists, mainly low-income people who are traveling by old motorbikes. Regulators have introduced motorbike banning plans for many years and are preparing a roadmap, but in practice this is exceedingly difficult for several reasons. The most direct reason is that

motorbikes are very convenient given the current condition of Vietnam's roads. They provide quick travel options and are convenient to park. Furthermore, people do not believe that banning motorbikes will help fully address the air pollution issue. Meanwhile, the public bus system does not provide wide coverage, especially away from main thoroughfares.

Grant #2 under this RFA seeks to address these challenges and achieve the following objectives:

- Build a network of government, business, and community actors that works together through coordinated activities towards a common agenda of reducing air pollution from road transportation
- Enable development and application of innovative technology, tools, and approaches to reduce air pollution from road transportation and mitigate its impacts, including through public-private partnerships.
- Identify opportunities for research on specific health risks from air pollution from road transportation (further grant funding for such research activities will be funded separately through Reducing Pollution) and/or the impact of road transportation on indoor air quality

Grant #2 will focus on the following geographic locations:

- Hanoi and Ho Chi Minh City

## SECTION 2: GRANT INFORMATION

### 2.1 ANTICIPATED NUMBER OF GRANTS TO BE ISSUED

The USAID Reducing Pollution Project expects to award 2 grants under this RFA but reserves the right to award fewer or none based on the quality of applications received and availability of funding. **One grant will be for a collective impact initiative focused on reducing air pollution from open burning, and one grant will be for a collective impact initiative focused on air pollution from road transportation.**

### 2.2 ANTICIPATED START DATE AND DURATION OF GRANTS

The anticipated period of performance for individual grants is a maximum of 36 months from the date of award, depending on the negotiated award activities.

### 2.3 ESTIMATED AMOUNT OF GRANTS

The estimated amount to be awarded for an individual grant is between US\$100,000 and \$125,000 equivalent per year. However, the final amount awarded will depend on activities and final negotiations. The maximum amount for 36 months is \$375,000. All awards will be negotiated, denominated and funded in Vietnam Dong.

### 2.4 TYPE OF GRANTS TO BE ISSUED

Winrock will determine the appropriate grant mechanism, in consultation with the applicant during the negotiation process, based on the pre-award assessment of the applicant, nature of the award activity, and estimated total cost of the award.

## SECTION 3: ELIGIBILITY INFORMATION

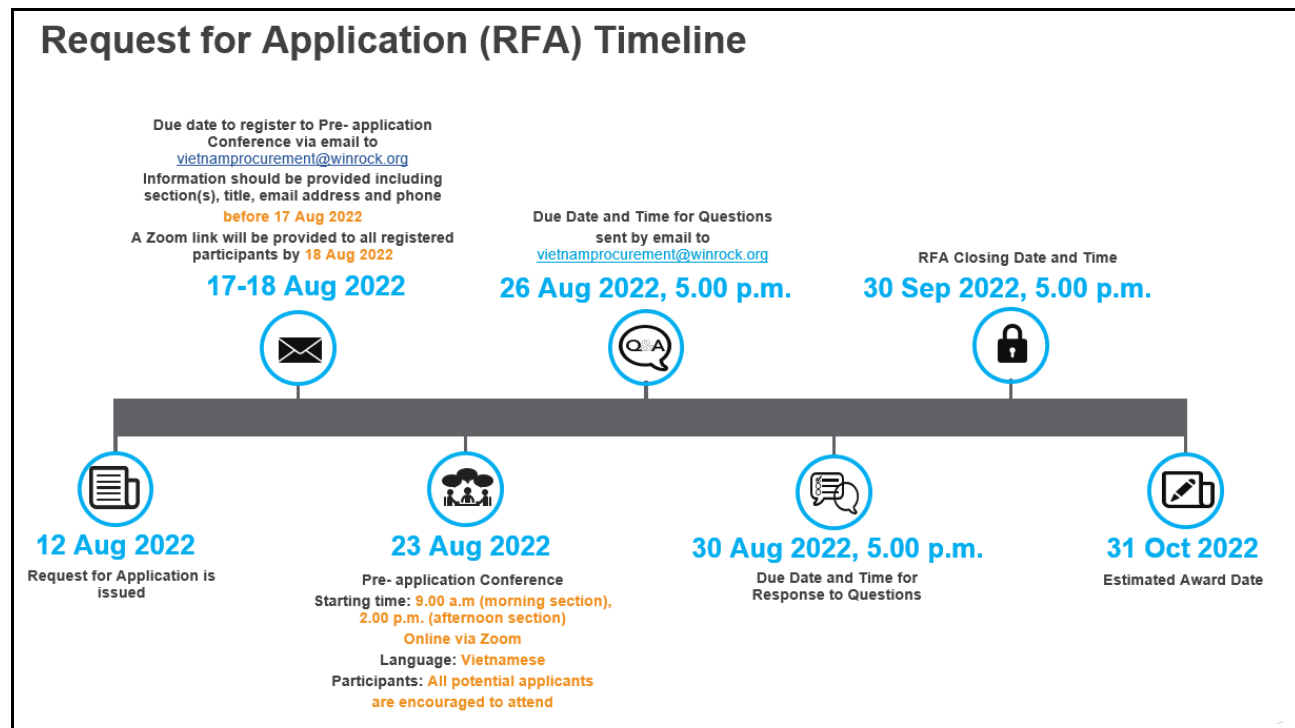
### ELIGIBLE APPLICANTS

This solicitation is open to Vietnamese non-governmental organizations. This can include traditional not-for-profit NGOs, social enterprises, or similar local organizations. To be minimally eligible for funding, applicants must comply with the following conditions:

- Be legally registered or otherwise authorized to conduct business in Vietnam.
- Agree to be subject to a pre-award assessment to examine that the applicant has sound management in the form of financial, administrative, and technical policies and procedures.
- Provide a SAM Unique Entity ID (UEI) number at the time of award. If the applicant already has a UEI number, it should be included in their application. Otherwise, applicants will be expected to get a UEI number before an award is issued. UEI numbers can be obtained online at <https://www.sam.gov>
- Does not have an active exclusion in the System for Award Management (SAM) - refer to <https://www.sam.gov/SAM/>
- Does not appear on the Specially Designated Nationals (SDN) and Blocked Persons List <https://sanctionssearch.ofac.treas.gov/> maintained by the U.S. Treasury for the Office of Foreign Assets Control (OFAC), sometimes referred to as the “OFAC List”.
- It is not on the United Nations Security Designation List <https://scsanctions.un.org/search/>

## 4.2. SUBMISSION INSTRUCTIONS

This RFA covers the overall topic of Collective Impact to Reduce Air Pollution. The Reducing Pollution Project has prioritized two priority sources of air pollution to include in this RFA: open burning and road transportation. Through this RFA, the Reducing Pollution Project will issue two separate grants – one for each source.

Applicants may choose to submit one proposal for one topic. If an applicant would like to submit a proposal for both topics, they must submit separate proposals for each topic.

### TECHNICAL APPLICATION

Applicants will develop their applications based on their understanding of the initiative's needs, their prior institutional experience and their determination of the approaches that would be feasible and successful. In all cases, applicants shall clearly explain the rationale for the proposed approaches chosen.

Submissions must clearly state the objectives and the expected results of the activity within the life of the funding period and define an implementation plan with a proposed time frame and budget. On-going monitoring and reporting of the funded activities will be the responsibility of the applicant. An Application Form template, [Annex A](#), is provided as an attachment to this RFA.

### COST APPLICATION

Cost applications shall be submitted separately from the technical application. Applicants shall submit:

- i) A summary budget table ([Annex B](#))
- ii) A detailed budget in Microsoft Excel with budget notes in column G ([Annex C](#)) to:

provide elements of the proposed activity with sufficient detail to determine if the cost estimate is reasonable and based on supportable facts rather than guesswork. Specifically, budget notes must identify, justify and/or explain:

- each type of unit used,
- the number of units proposed,
- the cost per unit,
- how costs were derived (determined to be reasonable). Costs need to be based on actual quotes, prices paid, or experience. If costs are based on historical knowledge or recent experience, the justification should state by whom the information was provided, when the quoted experience occurred for reviewer easy to understand,
- explanation why each budgetline/cost is necessary; how it matches with the activities proposed in your organization's technical application,
- cost norms to be applied in the budget should be consistent,
- budget for activities should include all expenses for each activity in big category line.

Note: The budget notes are very important to help the reviewers understand why an item of cost is necessary and how it will be used to support the activity for which it will be incurred. The budget notes should demonstrate the relationship between the proposed activities and the budget.

### COST-SHARE

Cost-share refers to additional resources that the applicant contributes to the total cost of the application, in addition to the requested budget amount of the submitted application. Cost-share is required for grant(s) awarded under this RFA.

Applicants are required to provide cost-share of 10% of the grant value demonstrating their commitment to the proposed grant activities in order to be competitive. Cost-share may be in the form of cash or in-kind contributions, including real property, equipment, supplies, and other expendable property or expenses of other non-USG projects that have similar goals and objectives that are implemented by the Applicant. Other examples of cost-sharing include volunteer services and donated office/venue space. To be counted, a cost-share contribution must:

- Be verifiable – The applicant must be willing and able to provide sufficient documentation to support all recorded cost-share.
- Not included as contributions for any other USG-assisted program.
- Necessary and reasonable for efficient and proper accomplishment of the objective(s).

## SUBMISSION GUIDELINES

Applications may be submitted in Vietnamese or English using the form provided in Annex A, B, C and may not be more than 30 pages, using Arial 10pt, single spaced. The page limit does not include Annexes and CVs of proposed staff included as part of the application.

Applications (including a technical description, estimated budget, and supporting documentation) must be submitted electronically via email to [vietnamprocurement@winrock.org](mailto:vietnamprocurement@winrock.org) with subject line: RFA 01 – Air-pollution\_ Road Transportation [your organization name] or RFA 01 – Air-pollution\_ Open Burning [your organization name]

Applications must be submitted no later than the time and date indicated on the cover page.

Incomplete or late applications will be marked as such and will be ineligible for review or award; however, Winrock reserves the right to accept and include incomplete or late applications in the review and award process when it is considered within the best interest of Winrock to do so. Applications that are submitted late or incomplete run the risk of not being considered for review.

Applications may be withdrawn by written notice via email received at any time before an award is made. Applications may be withdrawn in person by an organization or its authorized representative if the representative's identity is made known and the representative signs a receipt for the application before the award is made.

To be considered eligible for review, at a minimum, a complete submission package will have the following:

- Received before the closing date and time
- A copy of applicant's valid legal registration
- A completed technical application
- CVs for proposed key personnel with signatures
- A summary Budget table in Microsoft Excel or Microsoft word
- A detailed budget in Microsoft Excel

Receipt time for electronic submissions is when the application is received by Winrock's Internet Server. Hand delivery and hardcopy paper submissions of the application will not be accepted after the stated time on the cover page. Please do not send files in ZIP, RAR format.

By responding to the RFA, applicants agree to a pre-award assessment to examine that the applicant has sound management in the form of financial, administrative, and technical policies and procedures.

## SECTION 5: APPLICATION EVALUATION AND REVIEW PROCESS

### TECHNICAL REVIEW

The criteria presented below have been tailored to the requirements of this RFA. A total of 100 points are possible for all components of the application. The relative importance of each criterion is indicated by approximate weight by points.

In evaluating the applications, Winrock will examine overall merit and feasibility, as well as specific criteria relevant to each component as elaborated below. Awards will be made to the overall highest scores to the responsible applicant(s). Applicants should note that these criteria: (1) serve as the standard against which all applications will be evaluated, and (2) serve to identify the significant matters which applicants should address in their applications.

#### DISCLAIMERS

The issuance of this solicitation does not commit Winrock to make an award to any prospective grantee responding to this solicitation. Prospective grantees will not be reimbursed for costs incurred in the preparation and submission of an application. Winrock reserves the right to reject any and all applications, or to make an award without further discussion or negotiation.

All awards will be negotiated, denominated, and funded in VND. All costs funded under the grant must be allowable, allocable, and reasonable.

#### CONFLICT OF INTEREST
